— THE DETAILS

- We will only ever show you in a positive and respectful way, and we will never **sell** your image or pass it to an unrelated third party.
- Some places we post — Facebook, Instagram, TikTok, YouTube, LinkedIn — are run by overseas companies (mainly in the United States) that **store information overseas**. Once your image is on these platforms it is handled under their terms and the laws of those countries, which differ from Australian privacy law.
- Social media is public. Once something is posted, other people may see, share or save it, and we cannot always retrieve every copy.
- You can ask to **see and approve** the specific photo or post before we publish it — just let us know.
- This is entirely your choice. You are **not paid** for it and we offer no discount or benefit in return. If you are a patient, your decision **will not affect your treatment or care** in any way. If you are a team member, it **will not affect your employment** in any way.

— CHANGING YOUR MIND

This consent stays in place until you withdraw it. You can withdraw at any time by telling us in person, by phone or in writing. We will then stop using your image in anything new and remove it from material we control (our own posts and website) as soon as we reasonably can, though we may not be able to recover copies others have already shared or saved. If we ever want to use your image in a substantially different way, we will ask you again.

— YOUR PRIVACY

We are a health service provider and handle your personal information under the Privacy Act 1988 (Cth) and the Australian Privacy Principles. You can read how we handle your information in our privacy policy, or ask us for a copy. We store signed forms securely and keep them only while we use your image (plus any period the law requires).
